## **OLD BUSINESS -**

A. Our Solicitor, Andy Schmidt is moving from Quinn Law firm to Knox Law firm. After discussion on weather to continue with Attorney Schmidt or start with a new representative from Quinn Law firm. It was voted on a motion by Dillen, seconded by Campbell, to retain Andrew Schmidt.

## **NEW BUSINESS -**

- A. Jane & Joe Lenart, 5409 highland drive, voiced their complaints regarding Township Road crews unnecessarily trimming their pine trees along the road right-of-way. We trimmed too close to the tree trunk and too high resulting in ½ of the bottom tree limbs removed along the road facing side, the house/private property side was untouched. Suggested we raped her trees, degrading the value of her home/property.
- B. Conneauttee park playground area improvement; it was voted on a motion by Leehan, seconded by Burke, to purchase 12" tall playground plastic border, **Motion carried unanimously.** It was also voted on a motion by Campbell, seconded by Dillen, to purchase special playground mulch. **Motion carried unanimously.**
- C. After a brief discussion, it was voted on a motion by Campbell, seconded by Dillen, to purchase a high-pressure discharge hose for the Godwin pump from Sirco industrial supply, Erie PA. **Motion** carried unanimously.
