

WASHINGTON TOWNSHIP COUNCIL MEETING MINUTES – July 21st, 2026

CALL TO ORDER: Mayor Campbell called the Washington Township Council Meeting to order on July 21, 2026, at 4:30 P.M. at the Washington Township Administration Building at 11800 Edinboro Road, Edinboro, PA. Present were Vice-Mayor Dillen, Councilperson Malena, Councilman Vanco, Manager Willow, Zoning Officer Seaman. Guests were Dianna Markiewicz, Adam Honey and Jane Crawford- Edinboro Council Liaison.

AGENDA APPROVAL: It was voted on a motion by Vanco, second by Malena, to approve the agenda with the removal of the public hearing for CDBG. **Motion carried unanimously.**

COUNCIL MINUTES: It was voted on a motion by Campbell, second by Dillen to approve the regular meeting minutes of June 7th, 2026. **Motion carried unanimously.**
